

Introduction

We offer an exciting curriculum rich in first hand experiences. Some of these learning opportunities are expensive! On occasions we may ask for a voluntary contribution towards the cost as follows:

School visits out into the locality or visitors into school greatly enrich the curriculum and educational experience of our pupils. Unfortunately, many of these events incur costs, in particular transport costs. Staff strive to use the immediate locality as a source of positive first-hand experiences wherever possible so as to minimise costs. When organising school events, we ask parents to contribute towards the cost. Most events will have already been subsidised by school funds to cover the costs of adult helpers and to top up the amount of contributions received. If we do not receive sufficient voluntary contributions, we may cancel a visit or visitor. If a child is absent for the visit after making a contribution, monies will be refunded except for transport costs and theatre tickets, the cost of which will have already been made. Theatres do not make refunds. If a visit goes ahead, it may include children whose parents have not paid a full contribution. We do not treat these children differently from any others. Parents have a right to know how each trip is funded. We will provide this information on request.

Educational Enhancement Opportunities such as University of Life Experienced coaches, national and international dance/theatre companies and other professionals are invited to lead workshops for all pupils to learn new skills not normally available through a school curriculum eg engineering, beautician, photography. Costs are met from school budget.

Study Support

- a) Our Brainy Breakfast Club is available to all pupils on all school days and is currently charged at £3.00 per day.
- b) After school activities/clubs are available to all pupils. Some of these are led by staff and are free of charge. Others are led by professional coaches e.g. ProVizion Coaching and may incur charges for tuition at each session to be paid for by parents. Whenever possible funding is secured via the schools sports funding
- c) Holiday clubs: These are not held on our premises but are available at some local schools and Churches. These may incur a charge.

Food technology costs Parents may be asked to contribute towards the cost of ingredients. Pupils take home samples of what they have made.

Loss or damage to property or equipment The school environment should be respected and protected. Parents are asked to contribute towards the cost of lost or damage caused to reading books and library books. They may be asked to contribute towards the cost of other school equipment or property repairs if their child has caused this damage.

Nursery 30 hour provision

From September 2023 we will be offering a limited number of 30 hour places in our nursery. This means any pupil taking up the 30 hours in our nursery will stay from 8.30am – 2.30pm

(including 1hour lunch). We will be offering the option for these children to stay until the end of the school nursery day which is 3.30pm at a cost of £5.16 per day.

Inclusion The policy will be applied to all pupils.
